Dear Mayor Dickinson:

The State of Connecticut is offering once again grant funds through the Office of Policy & Management for municipal lighting improvements in municipally owned buildings. The application deadline is April 1 and no municipality is eligible for more than \$20,000.

As in the past the program provides for retrofitting of lamps and ballasts and the installation of motion control devices and timing devices for lighting control. Projects are ranked against each other using payback and savings calculations. Previously, lighting improvements were done in the Police Department, Main Street Fire Station and Senior Center.

In reviewing possible Town projects, it would appear that one project, Fire Central, would best meet the grant requirements. This project is estimated to cost approximately \$11,500 based on estimates done in 1994. Attached is a resolution for Town Council action.
