At this point in time, it is extremely difficult to give you a definitive answer to your inquiry of 1/30/84 as it relates to the Parker Farms Facility.

I would, however, urge you not to dispose of this property for the following reasons:

- The State Board of Education has approved a proposal, made by Commissioner Tirozzi, that would compel all Connecticut school districts to offer all day kindergartens. This mandate would commence with the 1985 school year. Should the General Assembly act favorably on this proposal, the Wallingford school district would require 8 additional classrooms. (When the Board of Education voted to close an elementary school last year, this proposal had not yet been contemplated by the State Department.)
- 2) In the near future, the Board of Education will initiate a comprehensive study of existing facilities and enrollment projections in order to determine long range building needs. This study is targeted for completion no later than June, 1985. Although the major focus of the study will be on the high schools, recommendations emanating from the report will have an impact on other levels. As you probably know, grade organization and/or reorganization is as much a factor of cost effective building utilization as it is educational philosophy.

If I can be of further help in this regard, please do not hesitate to contact me.

Approved Town Council Meeting Minutes of February 28, 1984

When you get a custodian for an outside activity, he is not being paid by the Town but by that activity or function. Of the \$17 paid for an outside activity, the custodian receives \$7 and the rest is for the paper work, etc. The average custodian in the Town of Wallingford is earning \$14,000. Try to support a family on \$14,000.

Mr. Parisi: I am not disagreeing with what you say. Though t public is paying the cost of the weekend or evening functions, many activities have had to be curtailed because of that cost. Though the It has been beyond the scope of non-profit organizations to pay this and it has been discontinued. It is not just you--there are other departments and unions who are also criticized and praised. Nobody means to imply that all custodians are bad and their work is too.

Mr. Gessert: You don't see the custodians who are performing their work but the one leaning against a wall does it in front of 1,000 people and that is what hurts.

Mrs. Bergamini: My point is that the dancing classes were held at a time when the custodian was on duty. I could never understand why we had to hire another custodian for that hour and one-half which was really a function for school children. That activity was cut out because it got too expensive.

Council members Bergamini, Diana, Killen, Krupp and Rys voted aye. Council members Gessert, Papale, Parisi and Vote: Polanski voted no and the motion was passed.

Mr. Parisi noted the correspondence, a letter dated 2/14/84 from Ronald M. Gregory regarding Resource Recovery which is noted.

Mr. Parisi read into the record a letter dated 2/9/84 addressed to Mayor Dickinson from Frank J. Soldan which is attached to these minutes as Attachment A.

Mr. Killen: I just want to note for the record that I lost my place and voted for the appropriation for the Professional Service and had not intended to. (Page 23 of 2/14/84 minutes.)

Mr. Krupp moved acceptance of the minutes of 2/14/84, seconded by Mrs. Bergamini.

Vote: All Council members voted aye except Mr. Gessert who passed and the motion was passed.

A motion was duly made, seconded and carried and the meeting moved into Executive Session to discuss a personnel matter and this portion of the meeting was adjourned at 11:20 p.m.

A motion was duly made, seconded and carried and the meeting moved out of Executive Session at 11:50 p.m.

The following vote was recorded:

Mr. Krupp moved authorizing the Town Attorney to settle claims in the amount of \$15,200, seconded by Mrs. Bergamini.

Vote: All Council members voted aye and the motion was passed.

Special Town Council Meeting

March 5, 1984

7:00 p.m.

A special meeting of the Wallingford Town Council was held in Council Chambers and was called to order by Chairman Parisi at 7:00 p.m.

Answering present to the roll called by Rosemary A. Rascati, Town Clerk, were Council members Bergamini, Gessert, Killen, Krupp, Papale, Parisi, Polanski and Rys. Councilman Diana arrived a few minutes late. Mayor Dickinson was also present. The pledge of allegiance was given to the flag.

Mrs. Bergamini moved to consider item (5) first so Mr. Soldan could attend another meeting. This motion was seconded by Mrs. Papale.

<u>Vote</u>: All Council members voted aye with the exception of Mr. Diana who had not arrived and the motion was passed.

Mr. Krupp: I will reiterate the same stand I took on this issue. I realize it is being brought up because there may be a change of heart on one of the votes the last time around. I still think the question of justification on a productivity basis is warranted on any contract that comes before us and I don't see it in this Fact Finder's Report and I think the 8% is excessive considering current circumstances.

Mrs. Bergamini: I requested that this be brought up again. After the last meeting, I read the contract again and decided that this was not the contract that I wanted to reject. I am not above sending a contract to arbitration and will put that to the test.

Mrs. Bergamini moved to reconsider the Fact Finder's Report in the matter of fact finding between Wallingford Board of Education and Council 4, Local 1303-60, AFSCMF. This motion was seconded by Mr. Gessert.

Mr. Parisi: I'd like to commend you, Marie, for your reconsideration and public statement that you were flexible enough to realize it wasn't truly what you wanted to do. I'm glad you did because I believe it is in the best interest of the Town.

Vote: Council members Papale, Parisi, Gessert, Polanski and Bergamini voted aye. Council members Killen, Rys and Krupp voted no. Councilman Diana had not arrived yet. The motion was passed.

Mr. Polanski moved to accept the Fact Finder's Report in the matter of fact finding between Wallingford Board of Education and Council 4, Local 1303-60, AFSCME, seconded by Mrs. Bergamini.

Mr. Killen: I would like to know your reasons, Marie.

Mrs. Bergamini: There are two reasons. I re-read it and also had in my hand the Board of Education budget. My points were made at the last meeting how certain conditions aggravate us and now that we have a Board of Education-Council Liaison, I am hoping that these items can be addressed and maybe we can win a few points with the next contract.

In this report, all they got besides the raise was an increase in life insurance and considering the benefits in this Town these days, that was minimal.

We have always been warned about going to arbitration. I did have a report given to me which included the results of certain arbitration cases and I could see the point. I decided that if I am going to make an issue of a contract, this is not the one to do it with--there wasn't that much money involved.

I could not argue with what they got after I started to read the Board of Ed budget. I decided I had made a mistake and decided to change my mind. •

Mr. Killen: I can concur with you on a lot of things. The problem is this has been around since the inception of the Council and each time one comes around, we're going to put our foot down. Each one has been living off the other. I don't want to pick on the custodians or the Fire Department or the Police Department but they are using one another. In the final analysis, by the time the next budget comes around, you and I may not be sitting on this Council and someone else will let it go by the board. I'm wondering where it is going to stop. Everything is compared to something else. I wish we could say, here is the job, here is what it is worth, here is the man and he is worth what we are paying him and that is what we are going to go by. Inflation is caused because we keep raising the prices and get nothing in return.

Mr. Parisi: A state-of-the-art today in negotiating is comparing other towns. I want to ask Mr. Seadale if it is possible for any Council members to attend bargaining sessions in the future.

Mr. Seadale: Under the last Council, the Mayor appointed Noma Beaumont who did sit in on some negotiating sessions, as an observer. Other than that, you would not be permitted.

Mr. Parisi: Perhaps in the future we might be able to observe. Quite frankly, if we are the financial body, I don't see any reason why we shouldn't be if we chose to be there for negotiations.

Mr. Seadale: You must be a member of the team to be there. Mr. Killen: The rules are laid down in Hartford for negotiations.

Mayor Dickinson: I don't have any problem as long as the spokesmen for the Town be permitted to exercise their judgment. It does require some expertise in labor negotiations.

Mr. Seadale: I think you would have problems with the law if you were going to participate in negotiations as a body.

Mrs. Bergamini: Just for the record, you are not allowed to.

Mr. Krupp: A point of clarification--this is in fact just a wage reopener, is it not? This is not a new contract and everything that was gained in the original negotiation in terms of increases in benefits, etc. continues in effect. Anything granted here is what was granted in addition to that original contract.

Mr. Seadale: This is the third increment of a contract which was a 39 months agreement.

Mr. Rys: I went along with the rejection of the contract because some of the taxpayers in Wallingford felt it was time the Council took into consideration the current inflation rate and felt that it was time that this Council said "no" and that is exactly the way I feel right now.

Mr. Polanski: What sort of raises did these people get 4 or 5 years ago when the inflation rate was 10%, 11% and 12%? These people are behind.

Mr. Seadale: As negotiators, I don't want to talk about the CPI. I am not going to sit here and do the union's work for them and tell you what they have lost or gained to the CPI. I have indicated to a couple of people on this Council who have come to me what in fact has happened to the custodians in the last 6 years. I am not going to do that publicly.

Mr. Parisi: This is a wage reopener and we are not discussing the approval or disapproval of a contract.

Mrs. Bergamini: When Mr. Seadale starts negotiating that contract with the Mayor, I would like to sit in and I understand I can sit in only as an observer.

Mr. Gessert: We end up with these things when it is too late for our input. Perhaps when the contracts come up, they can be reviewed with the Council for our input prior to negotiations so we might have some say on the final product.

Mr. Seadale: You might have a problem because of it being a legislative body.

<u>Vote</u>: Council members Bergamini, Gessert, Papale, Parisi and Polanski voted aye. Council members Killen, Krupp and Rys voted no. Councilman Diana had not yet arrived. The motion was passed.

Mrs. Papale moved an appropriation of \$4,800 from Unappropriated General Fund Balance to A/C 202-902 Professional Services Methane Gas Consultant. This motion was seconded by Mrs. Bergamini.

Mr. Gessert: I talked with one expert in the field who had heard of DeCarlo & Doll and said this is a viable solution to the problem and less expensive than some of the alternatives available.

Mr. Krupp: I also asked a friend who is a professional engineer who specializes in pollution control systems to review this. His opinion was that he doubted that he could come up with anything more effective for less money.

Mrs. Bergamini: I checked on DeCarlo & Doll and understand that their reputation is excellent, from three different sources.

<u>Vote</u>: All Council members voted aye with the exception of Mr. Diana who had not yet arrived and the motion was passed.

Mr. Gessert moved to waive the bid to award the balance of the contract to DeCarlo & Doll, Inc. for engineering design and field survey for methane deterrent system. This motion was seconded by Mr. Krupp.

Vote: All Council members voted aye with the exception of Mr. Diana who had not yet arrived and the motion was

passed. Mr. Parisi read item (4), consider an Ordinance Appropriating the Sum of \$150,000.00 for the Design and Construction of a System to Vent Methane at the Wallingford Landfill and Authorize the Issuance of Bonds and Notes to Defray Said Appropriation.

Mr. Killen: In the interim, can you find out if we will get \$150,000 from the Flectric Division, Mr. Chairman? This would eliminate going out to bond.

Mayor Dickinson: The matter of any excess money that may exist within the utilities is being discussed. It depends on what their budget looks like and there may be other more simple ways of addressing excess monies that should come to the Town. I would rather the extra cash be available. There are things that cannot be bonded, such as vehicles. The deficiency in workmen's compensation must be addressed within the utilities. If available cash is used on an item such as this which can be bonded, then the mill rate must be raised for some of these other items.

Mr. Killen: I still don't understand why all the monies collected don't go to the Town. That is what the Charter says. I've been pursuing this subject for 14 or 15 years.

Mr. Parisi: We will take it under advisement with the Comptroller.

Mr. Krupp: An ordinance is a public document and should be understandable by the public. Would it be unreasonable in the future to say instead of "defray said appropriation" to simply say "to provide for the funding of?"

Mr. Myers: I will check it with the Bonding Attorney.

Mr. Gessert: Let me commend Mr. Krupp--this is the first time he has put something in layman's language!

I would also like Mr. Myers to come back with some payment alternatives other than 20 year bonding.

Mr. Myers: The Mayor and I are trying to look at reasonable alternatives and possibly not issue bonds. We can borrow this money and let it remain on temporary notes and provide a principal payment of 1/20 of the issue immediately and in 4 years, pay it off at \$37,500 per year and never permanently bond it. We could borrow the money at approximately 7% which is about 2% less than permanent bond. This would certainly be to the credit worthiness of the community to show that we recognize our debt and in certain instances, we are providing for accelerated payment. Mrs. Papale moved to set a public hearing on March 13, 1984 at 7:45 p.m. on AN ORDINANCE APPROPRIATING THE SUM OF ONE HUNDRED FIFTY THOUSAND DOLLARS (\$150,000) FOR THE DESIGN AND CONSTRUCTION OF A SYSTEM TO VENT METHANE AT THE WALLINGFORD LANDFILL, AND AUTH-ORIZING THE ISSUANCE OF BONDS AND NOTES TO DEFRAY SAID APPROPRIA-TION. This motion was seconded by Mrs. Bergamini.

Mr. Polanski: How much money do we receive per year for the use of the landfill and does that money go into the General Fund?

Mr. Myers: About \$150,000. The money goes into the General Fund. Mrs. Bergamini: It is coming in a little higher, about \$13,000 or \$14,000 per month.

<u>Vote</u>: All Council members voted aye and the motion was passed. Mr. Parisi read and Mrs. Papale moved the following Resolution: A RFSOLUTION CONCERNING A CURRENT INDEX OF ALL ORDINANCES OF THE TOWN OF WALLINGFORD

WHEREAS a current listing of all Ordinances of the Town of Wallingford is required, both for reference and as an initial step in the development of a Code of the Town of Wallingford, BE IT THERFFORE RESOLVED by the Town Council in session that the attached listing, entitled "CONSOLIDATED ORDINANCE SUMMARY/STATUS RECAP," is recognized as the current comprehensive catalog of Ordinances of the Town of Wallingford, and reflects the current status of all Ordinances as of March 5, 1984.

AND BE IT FURTHER RESOLVED that the Town Clerk shall henceforth be responsible for the following:

- All Ordinances on file shall be reviewed and, where appropriate, any amending or repealing Ordinance noted on the affected Ordinance based on current status as reflected in the "CONSOLI-DATED ORDINANCE SUMMARY/STATUS RECAP" (hereafter referred to as "index") attached, such review to be completed by March 26, 1984.
- 2) The index shall be maintained by the Town Clerk as follows:
 - a) Upon the passage of any new Ordinance and the assignment of a file number, said file number, date adopted, and full title of the Ordinance shall be entered on the index.
 - b) If the Ordinance amends or repeals an existing Ordinance, the index shall be updated accordingly by entering an "A" (if amended) or "R" (if repealed) in the appropriate column next to the Ordinance affected, and entering the file number of the amending or repealing Ordinance in the appropriate column; in addition, the file number of such amending or repealing Ordinance shall be noted on the file copy of the affected Ordinance.
 - c) Copies of the updated pages of the index shall then be forwarded to the Town Council members, Mayor, Comptroller, Town Attorney, and Wallingford Public Library; in addition, a copy of the new Ordinance shall also be provided to the Wallingford Public Library.

IN ADOPTING THIS RESOLUTION, the Town Council also charges the Ordinance Committee with the responsibility to review existing and current Ordinances to ensure relevance to the current operation of government in Wallingford.

This motion was seconded by Mr. Rys.

Mr. Parisi: Mr. Krupp did a fine job on this and this will end up codified at no cost to the Town of Wallingford.

Mayor Dickinson noted it was a very good job.

Mr. Krupp: The master copy is available in the Town Clerk's Office.

Mr. Parisi: When the review of all Ordinances is completed by the Ordinance Committee, it will be presented to the Town Council.

Vote: All Council members voted aye and the motion was passed. (CONSOLIDATED ORDINANCE SUMMARY/STATUS RECAP ATTACHED, 34 PAGES.)

Mr. Killen moved approval of the Town Council Minutes dated February 28, 1984 and this motion was seconded by Mrs. Bergamini.

Vote: All Council members voted aye with the exception of Mr. Gessert who had left the meeting and the motion was passed.

Mr. Polanski: If the Council approves, arrangements will be made to televise the May 8, 1984 Town Council Meeting. This matter will be put on a future agenda.

A motion to adjourn was duly made, seconded and carried and the meeting adjourned at 7:40 p.m.
