4. Discussion and Possible Action regarding tentative agreement with AFSCME Council 4 Local 1183 from July 1, 2012 to June 30, 2016 - Personnel

In Attendance: James Hutt, Assistant Personnel Director Dennis Ciccarillo, Esq., Town's Labor Attorney

Following the points in his memo, Mr. Hutt reviewed the highlights of the agreement. Some of these memo points include- new hire sick leave accrual; elimination of terminated vested retiree sick leave payout; increase in insurance premium cost share; insurance co-pay increases in various settings; changes in funeral leave; life insurance increase; new hire longevity sunset; removal of Parks & Recreation executive secretary from the bargaining unit; new wage schedule increase of 1.95%-7/01/13; 1.95%-7/01/14; and 07/01/15-1.95%; funeral leave change; working crew leader hourly increase for 2014 & 2015 and a change in location of dispatcher breaks.

Council 4, Local 1183 unit includes Police Dispatchers and Clerical, Sewer and Public Works Employees.

The Town Council asked about a variety of items in the agreement including explanations of certain items and detail about others; such as health

insurance; longevity; wages impact; lays groundwork; bi-weekly pay checks as a talking/negotiating point.
