Wallingford Police Seize Cocaine & Marijuana During Crash Investigation

On February 18, 2021 at approximately 1:46 PM, Officer Knowlton of the Wallingford Police Department Traffic Division was dispatched to the area of 930 North Colony Road (RT 5), in the vicinity of the Stop & Shop Plaza to investigate a motor vehicle accident. During the ensuing investigation, and while speaking with the operator of one of the involved vehicles, Officer Knowlton smelled the strong odor of marijuana emanating from within the vehicle. The vehicle, a 2016 Mazda Cx-5, was operated by 29-year-old Stephanie Briscoe of Stamford CT. The front-seat passenger of this Mazda was identified as 42-year-old Keaon Major of Fairfield CT. During the pursuant search of Briscoe, Major, and the Mazda Cx-5, Officer Knowlton discovered the following contraband within the vehicle, and on the person of Major, some of which was packaged for sale;

Approximately one (1) pound marijuana in black vacuum sealed bag labeled "Fatso OG"
Approximately one (1) pound marijuana in black vacuum sealed bag labeled "Sour"
Approximately 135 grams marijuana in zip lock sandwich bag
Approximately 121 grams marijuana in vacuum sealed bag labeled "Jungle Cake"
Approximately 122 grams marijuana in vacuum sealed bag labeled "Peanut Butter"
Approximately 124 grams marijuana in vacuum sealed bag labeled "Jungle Cake"
Approximately 122 grams marijuana in vacuum sealed bag labeled "Peanut Butter"
Approximately 124 grams marijuana in vacuum sealed bag labeled "Sour Diesel"
Thirty-three (33) empty zip lock bags for packaging marijuana labeled "Peanut Butter Breath"
Stoney Gummies THC edibles
Zip lock baggies containing clear and pink vials containing cocaine (approximately 82.6 grams total, .7 grams each)
Zip lock bag containing three (3) individual bags of Psilocybin mushrooms (approximately 17 grams total)
Plastic bag containing four (4) individual bags of cocaine (119 grams total, approximately one ounce each)
Vacuum sealed bag containing approximately 35 grams cocaine
Four (4) individual bags of cocaine (approximately 40 grams total, approximately 10 grams each)
\$90.00 United States Currency, Four (4) Apple iPhones, and two backpacks

The above noted contraband had a combined total weight of nearly (10) ten ounces of Cocaine, 3.64 pounds of Marijuana, and 17 grams of Psilocybin mushrooms, with an approximate street value of \$35,000.00.

The accused, Keaon Major, age 42, currently of Fairfield CT, was placed in to custody and transported to Wallingford Police Headquarters where he was processed without incident.
