- 1. Discussion and possible action on August 23, 2021 special meeting minutes Minutes of the August 23 meeting were unanimously approved as presented.
- 2. Update: Scope of Work document for Old Railroad Station Staff Ryan gave an update on the progress of the Scope of Work document for the Old Railroad Station. Ryan and Jon Walworth, retired professional engineer, toured the entire facility. The Scope of Work document is a work in progress. Ryan will collaborate with the town's Purchasing and Law departments to refine the document. Document is expected to be finalized by November 5.
- 3. Discussion: Next column for Wallingford Magazine Staff Ryan stated that the article is a continuation of the Data Center series. The committee had a discussion on what should be included in the next article. The committee is in agreement that the next article should be a balance of facts and perspectives to address any public concerns, and to repeat the mathematics of the Data Center Municipal Host Fee Agreement.
- **4. Digital Channel Update** Staff Ryan gave a brief update that we have been sending out some digital incentives through Mail Chimp, Linked In, and Instagram. It has been a little bit of a slow process, but are working to improve the quality and quantity of digital content being sent.
