#### **RECORD OF VOTES & MINUTES**

The Regular Meeting of the Wallingford Town Council was called to order at 6:30 P.M. The Opening Prayer was offered by the Reverend Dean Warburton, First Congregational Church of Wallingford, and the Pledge of Allegiance was said. Councilor Fishbein was interested in where the items were in the budget; what are the "in-kind-contributions"; about the ownership of the facility; and the lease of the building. Mayor Dickinson reviewed the history of the Wallingford Community Day Care Center. There were questions about what is already owed the town. Comptroller gave a history of this funding for state day care facilities and agreed to look back at the status and make-up of the loan and the payment schedule over the last 5-10 years. He stated that the loan will be greatly reduced this year due to an expected payment of \$30,000 against the approximate amount of \$70,000 owed the town.

11. Discussion and Possible Action to Adopt the endorsement of the Town's recommendation for a new rail station location – Engineering

In attendance: John Thompson, Town Engineer

Councilor Cervoni noted for the record a Petition that was submitted from residents on North Cherry Street with regard to the Parker Street site for the railroad station. There are 12 signatures on the petition.

Mr. Thompson reviewed the two proposed sites for the location of the new rail station with the help of two displayed maps. He stated that the town recommends the Parker Street-Cerrito site (northerly of the current station) over the Ward Street-Judd Square site. Councilor Letourneau also made many good points regarding the opposite point of view stating that the Ward Street-Judd Square Site (southerly of the current station) should be selected. It was agreed that there were good points and negative points with respect to both sites. Discussion included emergency routes; number of trains; hours of trains; parking lots; station access from the lots; walking distances; traffic in the center of town and noise in regard for residents at either of the sites; what gates go down at what crossings when there is a train at either of the station locations; crossings were

identified as Ward, Hall, Quinnipiac and Parker Streets. Some Councilors stated that it didn't matter how they voted.

The following people spoke to this issue: Geno Zandri, gates issue; Michael Glidden with regard to the environment including possible disturbance of an archaeological site, landscaping, lighting, especially to those in 2-3 family homes and storm water runoff; Ray Ross; Dennis Doolittle about fencing between tracks and houses; Bob Gross, Fire Department preferences, police posted in quadrants; Wes Lubee, left out Council on review committee.

Attorney Farrell made comments to begin this discussion with regard to a request from the Council regarding subpoena powers of the Council to which he said that the Council does not have those subpoena powers. He said that when he and Attorney Small reviewed the motion that was passed that it did not identify what department was being investigated. He said the power of the Town Council is not to investigate employees. It is only to investigate a department or an agency and that it does not have any power to sanction, reprimand or otherwise discipline any town employees. He said that the motion also stated that it was to be an independent investigation. He asked that the Town Council be more specific of what it means by 'independent'. He said that the Police Chief did not indicate that anything criminal was involved so far as he could see and that there would be no criminal investigation. Also, the motion as passed was for a lengthy period of 3.5 years. The Law Department doesn't know where you want us to go – ideas of who might investigate, try to get prices, for example? He said that to do that the Council needs to limit what/where the investigation is and identify how independent it wants to be. It could also choose to conduct the investigation itself. He said that they spoke with other people including the town's labor lawyer who indicated that something like double jeopardy might apply. He said that these are the issues, and so it's back into the Town Council's camp of where it wants to go with it.

The discussion that followed was lengthy and often heated.
