5. PUBLIC QUESTION AND ANSWER PERIOD

Geno Zandri, 9 Balsam Ridge Circle, spoke about street lights that are out. He said hundreds of lights are out and that the taxpayer is charged even if a street lamp is out. He said he drove around for five minutes one evening and found 8 lamps out. He asked the Mayor why the Police, who patrol the town, could not note some of the lights that are out and report them. Mr. Zandri acknowledged that he is not asking for this to be a primary responsibility.

Robert Gross, 114 Long Hill Road, noted that the town did not receive the *Main Street* grant from the state for the refurbishment of the Simpson Court Rear parking lot. He added that the town also did not receive a *STEAP* grant. He then listed the towns who were awarded this grant along with their *STEAP* grants project. Mr. Gross named a few of Wallingford's projects that he thinks would fit the *STEAP* grant criteria for funding. He expressed disappointment that more grants are not applied for even if Wallingford is not awarded any.

Lucille Casagrande, 25 Turnberry Road, remarked that it is a known that one of the best deterrents to crime is well-lit streets. She thinks that the Police Department might be concerned with this. She was reminded about the Railroad station because she recently noted that there are six lights at the station and only one is lit. She continued by recalling an old tradition at the Victorian station of lamps that were lit in the windows and lights that were placed so as to follow the roof line. Work at the Railroad Station was

meant to enhance the green but now apparently the lamps are missing. She spoke about how she thinks things in town keep going downhill and that it is a problem, especially since she has such a great concern for the downtown. She said some things can be easily improved. She said if you want a beautiful downtown, then it has to taken care of it. She said it is not being taken care of. She thinks the priority is money. She posed this comment, if you look at your bankbook, it can be full of money, and you can have a Triple A bond rating, and you are able to borrow a lot of money. She said that you can be happy with that while you are letting everything fall apart because the main focus is money and how much you have. She said that as a citizen of this town, along with other residents, she is tired of it.

Larry Morgenstein, Main Street, asked about the Mayor's obligation and policy in terms of returning phone calls to people and said that he does not get responses to correspondence or phone calls.

6. Consider and Approve a Bid Waiver in the Amount of \$8,000 for *Kofile Preservation* for the preservation of old maps – Town Clerk

Mrs. Thompson explained that the Clerk's Office has some older maps that have gotten moldy and in disrepair. She contacted a Vermont preservation company that has been used for over 20 years by the Clerk's Office. She received an estimate of between \$7,000 and \$7,400, so she did not need to think about a bid. Once the funding was available, the company picked up the maps.

She then described a five foot by five foot map from the late 1800s of New Haven County that is significant and worth repairing but is in terrible condition. She said that the Engineering Department recommended that a copy be made so it can be reproduced for by title searchers, surveyors and the like. The cost will be approximately \$400, bringing the total to \$7,800 and over the bid threshold. She is asking for the bid waiver with a company that has worked for the town and is known by the town for 20 years and the fact that they now have the map for the twenty-week restoration process.

There were no comments from the Council or from the Public.
