Town Council Chambers FY 2015 – 2016 BUDGET WORKSHOP

MINUTES

The Special Meeting of the Wallingford Town Council was called to order at 6:30 P.M. The Pledge of Allegiance was said. Councilors in attendance were: Chairman Vincent Cervoni and Councilors Craig Fishbein, Tom Laffin, John Letourneau, Christine Mansfield, Robert F. Parisi, and Larry Russo. Councilors John Sullivan and Vincent F. Testa, Jr. were absent from the meeting. Mayor Dickinson and Comptroller Bowes were at the meeting.

3. BUDGET WORKSHOP

CONSERVATION COMMISSION

In attendance: Erin O'Hare, Environmental Planner Mary Heffernon, Chairperson, Conservation Commission

The Council discussed the use of the Conservation Commission computer; having trails online is helpful; Natural Resource Services; three projects this year-Pink Trail at Muddy River, Riparian Buffer at Doolittle and Ecological Management at Tyler Mill Preserve. It was reported that the town has 400 acres in farmland.

PROGRAM PLANNING

The staff line has an increase to allow for the minimum wage increase where seasonal and Work-Study Program are concerned.

GOVERNMENT TELEVISION

In attendance: Scott Hanley, Manager Government Television Don Roe, Program Planner

The server upgrade using the Lenox OS and Windows 7 was address; Part-time workers number six; who supplies production assistance for BOE meetings was asked to which Mr. Hanley responded that the Town supplies two and the BOE one; Capital item of \$15,000 was not used this year for a studio upgrade and will be carried forward to FY 2015-16; it is not likely that the server will last the year; the server plays back all of the shows that Government Television produces on Channel 20, such as 33 Town Council meetings, 7 BOE meetings plus five other land use meetings.

YOUTH & SOCIAL SERVICES

Mr. Turner addressed a number of areas - Youth employment Program, seasonal help. Dry dock did not apply for grant this year and only half of the \$10,000 was used this year; \$7,000 was allocated to increase mental health line. Dry Dock moved to Durham. How many homeless people are there? Overtime was discussed.
